THE ISLAND RESILIENCY ACTION CHALLENGE at CREF 2019 | 16th October 2019

An action-oriented stakeholder meeting hosted by Advanced Energy Group & New Energy Events

As island leaders contend with vital decisions around how to harden and make climate-vulnerable grids more resilient, consensus is often hard to achieve. Breakthrough results come from the alignment and accountability of critical stakeholders. Against this backdrop, Advanced Energy Group and New Energy Events, the organizers of CREF 2019, will convene the Island Resiliency Action Challenge at CREF 2019. Gathering island policy-makers, regulators, and utilities, along with international providers of finance and expertise, the intended outcomes of the action-oriented Island Resiliency Action Challenge are three-fold:

- 1. Collaboratively triage regional resiliency challenges
- 2. Identify the most critical immediate actions we must challenge ourselves to accomplish.
- 3. Leverage this action challenge into a collaborative, stakeholder engagement platform to assist other island communities and other extremely vulnerable cities, like Miami.

The desired outcome is a breakthrough resolution comprised of three time-based action items that must be completed within a year that best addresses the most critical regional resiliency challenge as identified by real-time consensus.

Action Challenge Format

I. Defining the Critical Problem:

Regional and industry leaders will have five slides and eight minutes to pitch a resiliency problem statement (300 characters or less) for which the entire group should focus on finding immediate, short term solutions.

II. Defining the Critical Solutions:

Roundtable Discussion Leaders will lead roundtable participants through an exercise to identify a critical short-term solution set and then pitch to the general audience for a vote.
