- ▶ Act 17-2019 (Puerto Rico Energy Public Policy Act) included the creation of the Green Energy Trust Fund, which among its objectives is to financially support projects that provide access to green energy to residents in low and middle-income communities, as well as to promote the strengthening of the culture of saving and efficient use of energy, among others.
